- Upon acceptance by the RIAF committee, a member of RIAF will contact the selected applicant to discuss and finalize performance times, payment to perform (if any), etc.
- Sound and lighting will be provided on the main stage. A PA system will be provided on the small stage
- Festival hours: Friday (10/1/21) 12:00pm-8:00pm, Saturday (10/2/21) 10:00am-8:00pm. Sunday (10/3/21) 12:00pm-4:00pm
- Musicians will be required to check in at least 30 minutes before their allotted set up time
- **Music/Performance must be family friendly**
- Contract: All musicians and performers are to complete a Contract to Perform at RIAF 2021, specifying names of musicians or performers, amount to be paid (if any), performance time, etc. Contract is to be completed after acceptance by RIAF committee
- CANCELLATION: In the event a musician or performer is unable to honor their commitment to perform, they are to contact the Coordinator of Performers ***immediately*** so another individual or group can be scheduled for that time slot. If there was to be payment, it would be forfeited
